**Specialist Grade-II (TB & Chest Diseases) 1(One) [Reserved for OBC]**

**Essential Qualification:** (i) A recognized medical qualification included in the I or II schedule or Part-II of the third schedule to the Indian Medical Council Act of 1956. (Persons possessing qualifications included in Part-II of third schedule should also fulfill the conditions specified in sub-section of section 13 of the Act). A postgraduate qualification e.g. M.D. in TB and Respiratory Diseases from an Indian University or qualification recognized equivalent thereto. OR Diploma in TB and Chest Diseases.

**Experience:** 3 years experience in TB and Chest Diseases in a recognized Institution after obtaining the qualifying degree of MD (TB and Respiratory Diseases). 5 years experience in TB and Chest Diseases in a recognized Institution after obtaining the Diploma

**Note I:** The Medical qualifications possessed by the candidates should have the recognition of the Medical Council of India.

**Note II:** Holders of speciality Board of USA qualifications should complete the entire requirements of the Board concerned.
