- 1. The candidates are required to bring the duly filled application format in CAPITAL LETTER provided at annexure-A, and the original documents along with self attested photocopies of the following documents
  - a) Proof of date of birth i.e. Birth Certificate/Matriculation
  - b) MBBS/BDS Degree
  - c) Internship Completion Certificate
  - d) DMC/DDC Registration Certificate.
  - e) Reserve category certificate i.e SC/ST/OBC/EWS/PwD.

## 2. Eligibility Criteria for Junior Resident: -

- MBBS/BDS Degree from a recognized university or equivalent qualification recognized by MCI/DCI and registered with Delhi Medical Council/ Delhi Dental Council (DDC).
- 2 Candidates must have completed their internship on or before 16.01.2023.

- 3 DMC/DDC Registration is mandatory at the time of joining.
- Those who have completed one year Junior Residency in any Govt. Hospital need not apply.
- 3. Age as on 16.01.2023: Not more than 35 years, the age is relaxable for SC/ST/OBC/EWS/PwD as per rules (GOI).
- **4. Appointment & Tenure:** The tenure is purely on temporary basis for a period of 06 Months extendable upto one year.
- 5. **Emoluments Per Month:** Salary based under 7th CPC level-10 of pay matrix, on the Revised Basic Pay of Rs. 56100/- + NPA + Usual allowances as admissible. Residence shall be provided, if available.
