2. Candidates who have passed GNM/ B.Sc. Nursing will be selected for 4 months CPCH course based on performance of the candidates in screening test and interview. After successful completion of the CPCH course they will be posted as CHO in any SC-Suswasthya Kendra, based on merit cum choice counseling against selected Sub centre as per vacancy / requirement.

## Note: Degree through Distant Learning course or from any Open University will not be entertained.
