## **CIRCULAR**

Subject: Filling up of the 05 (Five) vacant posts in the grade of Community Based Rehabilitation Worker in Dr. Ram Manohar Lohia Hospital, New Delhi by Deputation (including short term contract).

05 posts of Community Based Rehabilitation Worker (Group 'C') Non-Gazetted, Non-Ministerial in the level-4 of Pay Matrix Rs.25500 – 81100 is proposed to be filled in Dr. Ram Manohar Lohia Hospital by Deputation (including short term contract). The eligibility for the post is given in Annexure-I. The period of deputation shall initially be for a period of two year but in any case shall not exceed 3 years. The pay of the selected candidate will be regulated in accordance with the orders of Govt. in force as amended from time to time.

It is requested that applications of suitable candidates who are eligible, willing and can be spared immediately, may be forwarded to the undersigned within a period of forty five days, in the prescribed pro-forma (Annexure-II) through concerned cadre controlling authority. The cadre controlling authorities should carefully check the applications and ensure that they satisfy the eligibility conditions before forwarding the same to this office. The application must be supported with the vigilance clearance and up to date ACR dossier.

Application without Vigilance Clearance and up to date ACR dossiers will not be considered.

- (b) Possessing the educational Qualifications and experience prescribed as under:
  - (i) 12<sup>th</sup> Class pass from recognized Board.

(ii) One year Certificate course of Multi Rehabilitation worker or Community Based Rehabilitation Worker from a Government institution or Non- Government organization or private institute recognized by Rehabilitation Council of India.

#### Desirable:

One year experience in any government Institute Or Registered Non-Government working in the Disability field.

- Note 1:The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.
- **Note 2:** The maximum age-limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
- **Note 3**: The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
