Kochi Metro Rail Limited (KMRL) a 50:50 Joint Venture of Government of India and Government of Kerala incorporated for the implementation of the Kochi Metro Rail project in Kochi and for its operation & Maintenance intends to appoint the following official:-

The incumbent shall be a member of the Board of Directors of KMRL and will report to the Managing Director of the Company.

He/She will be responsible for the overall planning of Systems (Rolling Stock, S&T, Electrical, Depot & workshop) for the project including consultancy, design, tendering, contracting, planning & executing and commissioning of Systems. He/She will also be responsible for Overall project administration with regard to Systems, Project monitoring, Interface management, Quality assurance, Safety, Cost control for Systems. He/She shall also be responsible for Operations and Maintenance of systems and Depot & Workshop,

Essential

The applicant should have a BE/ B Tech/ BSc.(Engg.) in Electrical/Mechanical/Electrical & Electronics Engineering/Electronics & Communication Engineering discipline, from recognized Institution or University.

Experience

Essential :

i) Proven track record of twenty-five (25) years after graduation in Electrical / Mechanical / Electronics and Communication Engineering service in Group 'A' Service in Indian Railways or Executive service in Railway PSU's/Subsidiary/Sister Concerns. Out of 25 years mentioned, five (5) years' experience should be at senior levels in Railway/Metro electrification works/Rolling Stock/Signalling & Telecommunication projects of large nature.

ii) Should have experience and knowledge of inter-facing with railway or metro related disciplines such as track laying works, signalling, electrification and rolling stock, etc.

iii) The applicants should have experience in preparing tendering / contract management and project management of important electrical structures and / or signalling and telecom systems from domestic and international vendors as a team leader.

iv) Should have proven experience and knowledge in handling Metro Rail Operations or EMU or Rail operations.

Desirable :

Experience of all phases of major rail based urban transportation projects on contracts i.e. Planning, Bid Documents, Bidding, Execution, Commissioning, post Commissioning, etc.

Experience of implementing major projects and complying with project related requirements of international funding institutions.

(III) <u>Minimum requirements on scale of pay (to be reckoned as on</u> 01.04.2023)

 a) Public Sector Executives in the pay scale of Rs. 120000 – 280000 (Revised), or, Rs.51300-73000 (Pre-revised IDA) or equivalent pay scale certified by the Competent Authority, or higher.

 b) Government Officers working in level 14 of the 7th CPC or Senior Administrative Grade (SAG) (with Grade Pay of Rs.10000 CDA of Rs. 37400-67000 (Pre-revised), or higher. - c) The Disciplinary and Vigilance Clearance of the Candidates certified by the present employer should also be enclosed.

No application shall be entertained under any circumstances after the stipulated date. Incomplete applications, applications not in format, applications received after the stipulated date, shall be REJECTED. KMRL reserves the right to shortlist the applicants for interview. The decision of the selection committee shall be final. Only Indian Nationals shall be eligible to apply.
