CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03 (Three)** position(s) of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year (Project duration for 3 Years)** or till the project is over on a temporary contractual basis in the project entitled “**Formulation and product development of Ayurveda recipes and nutritional evaluation of selected products**” (GAP-0634) tenable at the Department of **Traditional Foods & Applied Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

3. The engagement will be contractual and purely on temporary basis for a period of 01 Year, or co-terminus with the project, whichever is earlier.
