4. Department will not be responsible for any postal delay/wrong delivery. Incomplete/incorrect/without signature applications will be rejected without any notice.
5. Applications from employees working in Central/State Govt. Departments / Public Sector Undertakings and Govt. funded research agencies must be forwarded through proper channel.
